WHO SHOULD ATTEND?

All personnel working on the roadways should attend these sessions, including roadway maintenance workers, traffic device installation/maintenance personnel, and street/sidewalk maintenance personnel. Others who occasionally work on or near roadways, such as staff from utilities, public works, sewer, bridges, parks and recreation and roadside landscaping, will benefit from this training, as well. There is no experience or prerequisite required for the 16-Hour TTC/MOT intermediate course.

TTC/MOT INTERMEDIATE COURSE

Duration: 16 hours

Overview

To ensure every person involved with work zone traffic control understands the standards with regard to planning, designing, supervising, implementing and maintaining work zone traffic control.

The course curriculum covers TTC/MOT procedures and principles, and includes classroom training, problem solving and a written test.

Learning Objectives:

- ▶ Explain the four areas of a work zone and the traffic control devices used in each;
- ▶ Understand the requirements for national and Florida standards for work zone traffic safety;
- ▶ Interpret and apply the Roadway and Traffic Design Standards (RTDS) typical applications to varying work zone situations; and
- ▶ Inspect the placement and/or operational function of work zone traffic control devices as defined by RTDS.

Participant Profile: All work zone workers.

TTC/MOT certification wallet cards, which are valid for four years from the date of the exam, will be issued to individuals who successfully complete this course.

TTC/MOT INTERMEDIATE 8-HOUR REFRESHER COURSE

For TTC/MOT certification wallet card holders, the 8-Hour TTC/MOT Refresher Course is required every four years to recertify. Recertification lasts for four years. Note: Refresher course must be successfully completed before certification expiration as listed on wallet card.

Duration: 8 Hours

Prerequisite:

This course is designed for personnel who have successfully completed training in the 16-Hour Temporary Traffic Control/Maintenance of Traffic Intermediate Course, hold a valid and verifiable wallet card and are near their recertification due date.

Overview:

This course consists of a review of Temporary Traffic Control/Maintenance of Traffic procedures and principles and includes classroom training, problem solving and a written test.

Learning Objectives:

To ensure course participants are knowledgeable of Temporary Traffic Control/Maintenance of Traffic Intermediate procedures and principles.

Participant Profile:

Personnel who have successfully completed the 16-Hour Temporary Traffic Control/Maintenance of Traffic Intermediate Course, hold a current valid and verifiable wallet card, and are near their recertification due date.

TTC/MOT recertification wallet cards will be issued to those successfully completing this course.
